## INVESTIGATION:

Tour of the shop was given to the investigators by Vicky the owner prior to setting up investigation equipment..  
Video cameras were set up in the attic, basement and the back room. Radiation detector also utilized.

## SCIENTIFIC INPUT:

Digital cameras were used and many photographs were taken on every floor in every room. Team members reviewed all photos. None of the photos revealed any anomalies. All pictures were quite clear and in focus.

Video equipment listed above was used and no abnormalities were recorded.

All EVP session have been reviewed and no audible abnormalities were found.

### **PERSONAL IMPRESSIONS FROM TEAM MEMBERS:**

The following are personal opinions and observations not scientific by any means and merely offered by the team as documental information.

Team members thought it was interesting that a place as large as it is and with as many collectible objects in each room and the top floor containing so many boxes and furniture piled up that photographs did not show any dust orbs. There were many people walking throughout the store at different times and could possibly stir up the dust but the cameras caught no dust orbs.

A personal experience happened in the book room. Vicky and Kathy went to the book room; everyone else was next door in the Holiday room. The room, which is approximately 10' x 10' has bookshelves on all walls with a table in the middle of the room with books and record albums on it. Vicky stayed at the doorway and Kathy walked into the room to the left, upon walking toward the back wall three books that were on the shelf, eye level, slowly fell over. They did not fall fast but almost as in slow motion. Kathy straightened the books and proceeded to do whatever she could to get them to fall again. Kathy even had one of the other investigators walk and stomp on the floor in the adjoining room. The books would not fall.

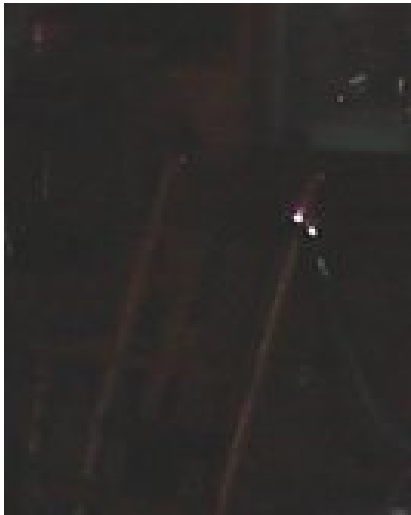
Throughout the night individual experiences were experienced but unfortunately there was nothing captured on video and there were not any audible evp's captured. At one point there were three investigators in the basement all visibly saw a white light flash across the wall. Kathy was video recording but unfortunately, it cannot be seen on the portion of the tape, there is a slight stream of light but is very hard to see and comes across as insignificant.

### **PROPERTY HISTORY:**

The owner has a very impressive collection about the history of the building that she compiled from various reputable resources. Team researcher visited the town library prior to the investigation and looked at some information they had about the building and it is listed in locally published brochures that identify downtown buildings of interest for historical walking tours. Team researcher shared this information with the owner who was unaware of its existence. The owner showed the team researcher printouts that listed genealogy information about the previous owners but could not verify the source of the document other than the local library gave it to her. Team researcher found this document on Church of Jesus Christ Latter Day Saints [Family.org](http://Family.org) website. (LDS are infamous for their genealogy work and databases) and it is believed to be accurate in content.

**CONCLUSION AND FINAL INPUT:**

Below is one picture that was taken of a rocking chair in the basement furniture room. There have been comments made that a face can be seen in the upper middle part of the picture. Not all investigators have been able to see this but three or more people have seen it without any forewarning of what was seen initially. Even though we do not have any corresponding scientific data it is believed that due to the numerous experiences that was had by all members of the team another investigation should be conducted in the near future.
