Client Report:

Preliminary Investigation:

Met with Brad who showed us the premises that would be investigated. It was decided that the upper level condo would not be investigated. Main level where a white shadow in back by salon has been seen would have a camera running along with 3 other camera's set up downstairs in the basement. Base readings were all within normal range except for one small area in the basement where there are fluorescent lights, emf readings were slightly higher than average. All other areas of the basement were steady and showed nothing abnormal.

Investigation:

Quad system was setup, camera one recording the front of the store, camera 2,3 and 4 were set up in the basement, one towards the corner cell, one aimed in the back room showing the rear exit door and one set up back to show the basement area in front of the 3 cells. Three different areas will be shown of camera's going black for no known natural reason.

Base readings, including temperature and emf levels were noted, nothing abnormal was documented.

Evp session's were done by both groups in all areas of the 2 levels that were investigated. Nothing is recognizable as an evp on any of the recordings.

Digital pictures were taken, one photo attached shows a bright lighted orb in the cell that personal experiences were had by all members of the team. There is no explanation for this lighted orb, pictures taken before and after this one photo showed nothing out of the ordinary.

Personal Experiences

There were numerous incidences that were experienced among them, noises of bangs and sounds of things being moved in the basement. At one point in the evening the elevator was activated on it's own. Feelings of sadness in the basement were experienced by 2 investigators at different time without the knowledge of each one experiencing the emotion. At 2 times during the evening 2 investigators, without any possible way of learning this from one another, both had a feeling and audible experience that the name of one of the men held in one of the cells was Victor and not Vince as it was believed to be. Please refer to the history that in fact a Victor was held in one of the cells for murdering his wife.
